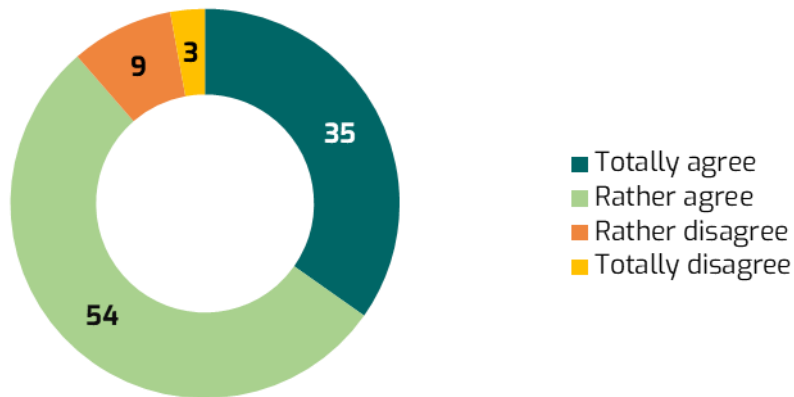


Figure 2. 'Q2. The results achieved by the Economic Council contribute to the increasing popularity of the platform among the business community.', N=75

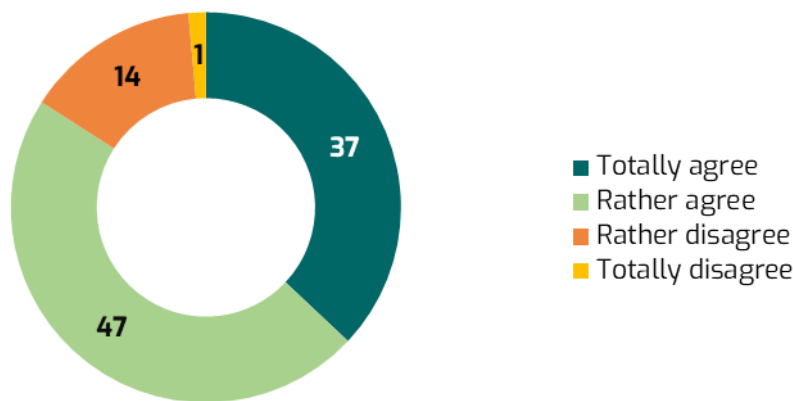


Figure 3. 'Q3. Economic Council promotes initiatives that correspond to the interests of business associations and good international practices.', N=75

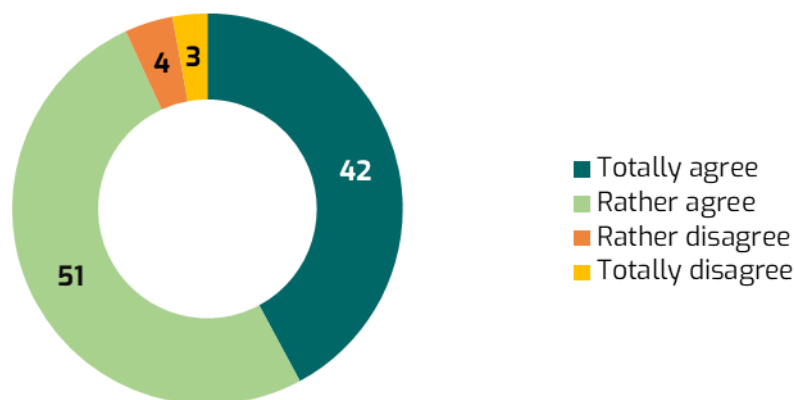


Figure 4. 'Q4. The Secretariat of the Economic Council liaises efficiently with the members of the Economic Council and the wider business community to identify key constraints to the business climate and on measures to address them (e.g. implementation of new business-supportive policy reforms, regulatory changes and/or legislative amendments)?', N=75

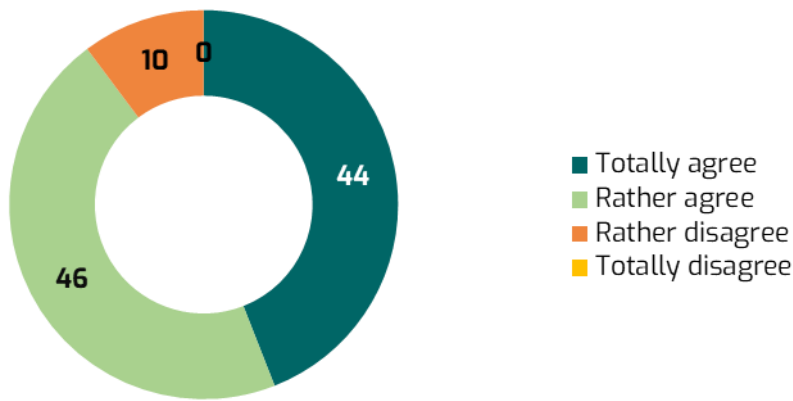


Figure 5. 'Q5. Do you consider the Economic Council an efficient mechanism to promote a dialogue between the Government and the business community? If disagree please explain in the box "Comments" below.', N=75

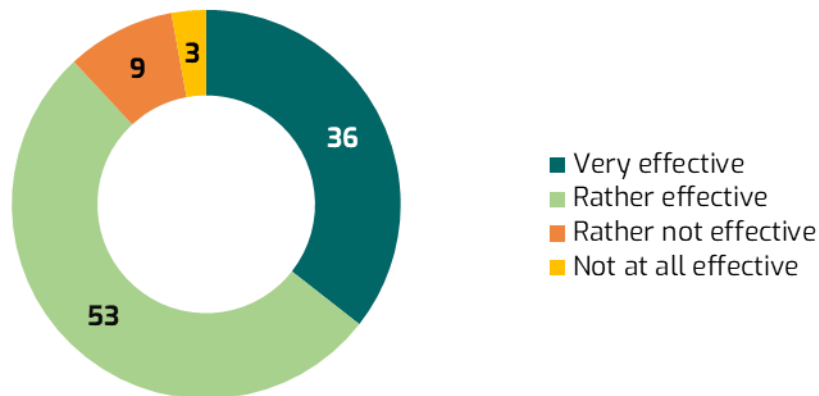


Figure 6. 'Q6. In conditions of political instability and changing political priorities, the Economic Council remains an effective tool in promoting pro-business reforms.', N=75

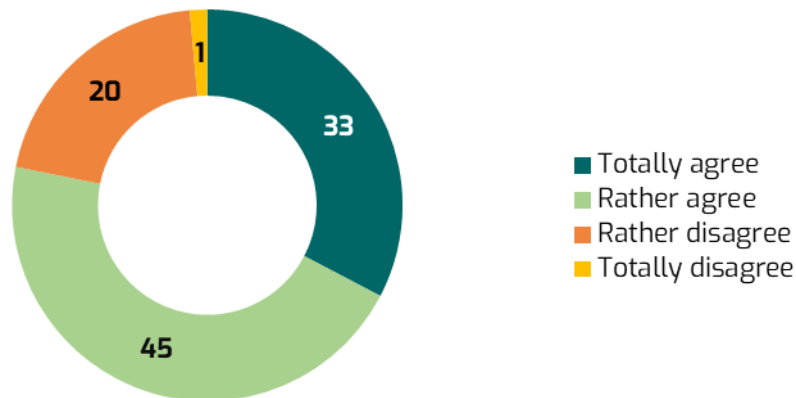


Figure 7. 'Q7. The Secretariat of the Economic Council is well engaged with the Government decision makers that enables better implementation of reforms' N=75

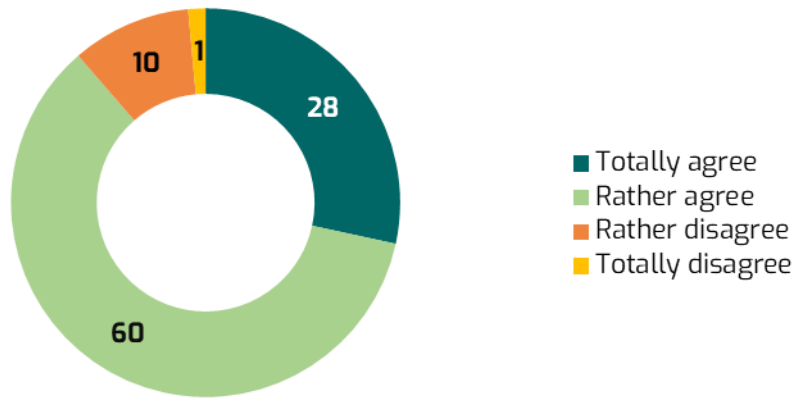


Figure 8. 'Q8. The Economic Council is promoting initiatives relevant for the process of digitalization of economy. If you do not agree, explain why in the "Comments" box below.', N=75

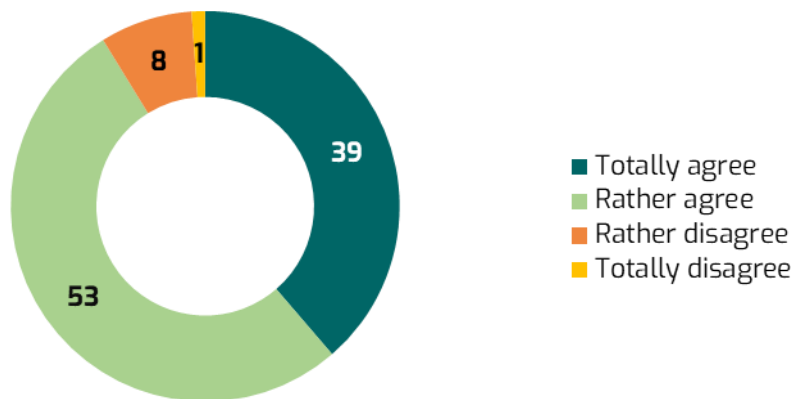


Figure 9. 'Q9. The Economic Council promotes reforms and initiatives that help strengthen women's empowerment in business.', N=75

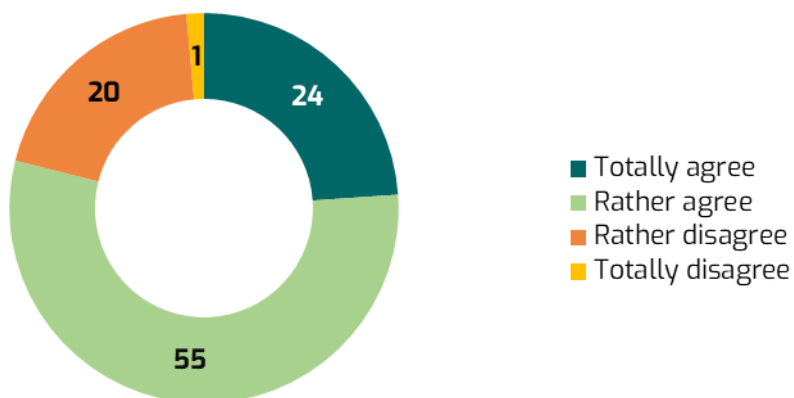


Figure 10. 'Q10. The Economic Council ensures an effective dialogue between the Government institutions and the Small and Medium Enterprises community in order to address the issues raised by SMEs.', N=75

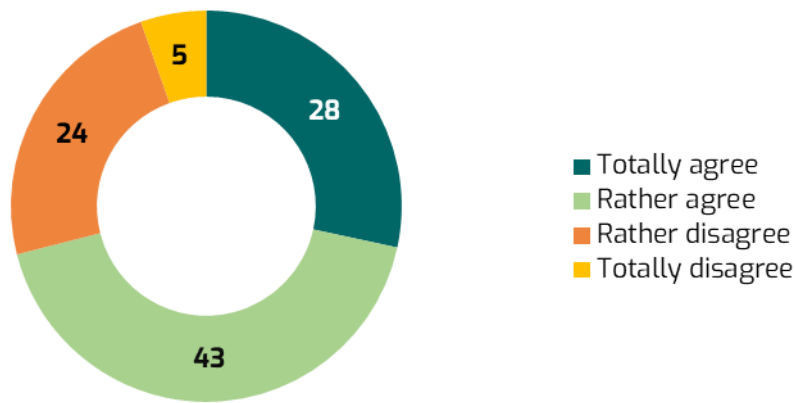


Figure 11. 'Q11. Membership of the EC is not sufficiently representative of the business community, leading to accusations of bias or partisanship..', N=75

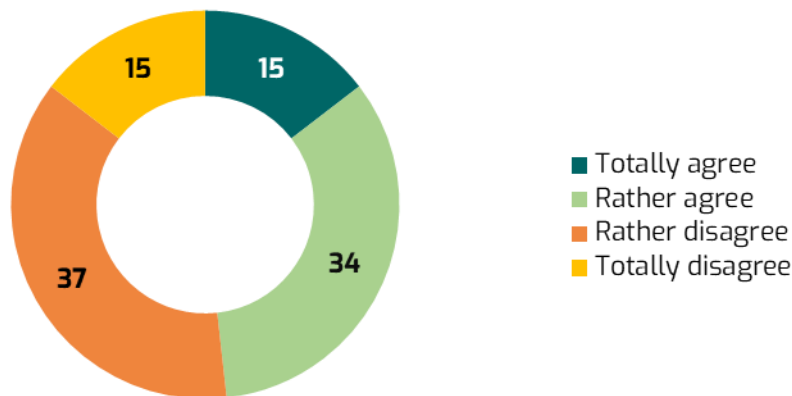


Figure 12. 'Q12. Has the business environment improved in the areas the Economic Council have undertaken its work? If disagree please explain in the box "Comments" below.', N=75

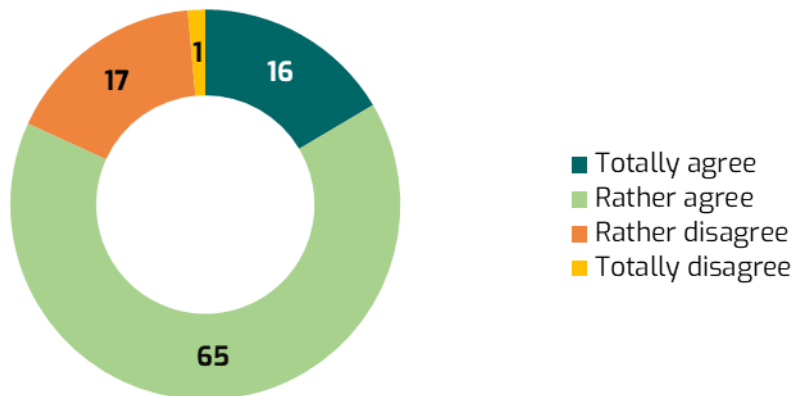


Figure 13. 'Q13. Economic Council is an essential tool in promoting economic reforms and it is important that it continues its activity in the nearest future.', N=75
